# **Course Syllabus**

## **Course Description**

This is a standard master's level course on microeconomic theory and covers fundamental concepts. This includes an examination of the way in which producers, consumers, and resource owners acting through the market determining the prices and output of goods, the allocation of productive resources, and an exploration of contemporary theoretical developments.

In this case, the weight will be reallocated onto other assessments. Exams missed for unexcused reasons will receive a score of 0.

#### **Grading:**

There will be weekly homework, a midterm exam, and a cumulative final exam. The breakdown of the final

grade of the course is as follows:

Homework assignments: 10%

In-class quizzes: 15%

Midterm: 35%Final exam: 40%

This can be translated to letter grades as follows:

```
100-97% A+ <97%-93% A <93%-90% A-
<90-87% B+ <87-83% B <83-80% B-

```

*Scaled Score*: Note that exams may be curved upwards (never downwards). For example, if a student's raw score on a test is 80 points, it may be curved to a scaled score of 85 points if the class average is low. If the exam average is high, then the raw score will not be adjusted. The scaling may not be uniform.

**Please note that assessment grades are final.** If you believe a calculation error has occurred or if you have a legitimate reason to question your grade, you may submit a regrade request. However, please note the following:

- Regrade requests must be submitted in writing within one week of receiving the grade. After this period, no regrade requests will be considered.
- When a regrade request is submitted, the entire assignment or exam may be re-evaluated, which
  means your grade could go up, down, or remain the same. This ensures fairness and accuracy in
  grading, and we encourage you to carefully review your work before requesting a regrade.
- Grades assigned after a re-evaluation are final.

**Assignment Policy:** Homework is an indispensable part of the course. Students are encouraged to work on the problem sets in study groups of up to three students, while also spending time to think about the problems on their own. To get any credit, **everyone must write up their own solutions**, and list all the team members in their homework submissions.

If you believe a question was graded incorrectly, please contact your Assistant Instructor.

**Exam Policy:** Exams will be in person, closed book. All calculators are allowed, except for those that can access the internet, such as TI Enspire Models. If you have questions about whether you calculator is allowed, please contact me.
