Course Description

Supervised, on or off-campus experience in a field directly pertaining to Economics, Econometrics & Quantitative Economics, or CS+ Economics. Students will complete course requirements along with a written report and possible presentation pertaining to their internship accomplishments at the end of the internship.

Prerequisites

There are no prerequisites for this course, but you must be a registered Economics, Econometrics, or CS+ Economics major.

Learning Outcomes

After completing this course, students will:

- Relate concepts and theories learned in previous coursework to the internship experience.
- Understand working in a professional environment and how to project a professional image.
- Acquire valuable work experience in the "real world."
- Be familiar with preparing a resume and cover letter for future job searches.
- Reflect on the relevance of the internship experience.

A Satisfactory grade will be awarded based on completing and submitting all assignments via Canvas by the final due date as well as submitting the reflection paper. In addition, students registered for the 3-credit hour option will need to complete the PowerPoint Presentation or Personal Website.
